BUILDING FEE SCHEDULE

Authority: The Building Department provides the City of London with inspection and enforcement to ensure safe structures. The standards applied are those of the *Ohio Building Code (OBC)* and the *Residential Code of Ohio (RCO)*. Authority to enforce was granted to the City by the State of Ohio, Department of Industrial Relations, Board of Building Standards, and by City Ordinance. London Building Department enforces the OBC and RCO. For all items inspected by the City, the applicant must provide five (5) sets of plans and specifications for commercial and two (2) sets for residential. A deposit of \$60.00 plus 1% will be required for all residential applications. A deposit of \$150.00 plus 3% will be required for commercial applications.

Plan Examination Fee: \$75.00/hour

0 – 2,000 s.f.: \$500.00. 2,000 s.f. – s.f. 4,000: \$750.00. >4,000 s.f.: \$1000.00 plus Ohio 1% fee and excludes fireplaces.

Accessory Structures / Decks / Pools / Fireplaces: \$100.00 plus Ohio 1% fee.

Minimum Permit Fee: Renovation in areas less than 100 s.f. for building or where a limited amount of work is to be performed for: Less than 6 electric fixtures / devices or <400 amp service or less than 6 HVAC fixtures / devices or tying into existing ductwork or signs (includes foundation / electrical and final inspection): \$150.00
