

PETITION FOR ALLEY CLOSURE/VACATION

Pursuant to London City Ordinance #209-13

To request that Council close/vacate an alley in the City of London, submit this petition plus:

1. a description of the alley to be closed/vacated, i.e. the property addresses abutting the alley and the streets between which the portion of the alley to be closed/vacated lies;
2. a map or drawing of the alley to be closed including the abutting properties;
3. a list of the names and addresses of all owners of property abutting the alley to be closed/vacated;
4. the signatures of all property owners that consent to the closure/vacation of the alley;
5. a non-refundable filing fee of seventy-five dollars (\$75.00).

to the next alley.



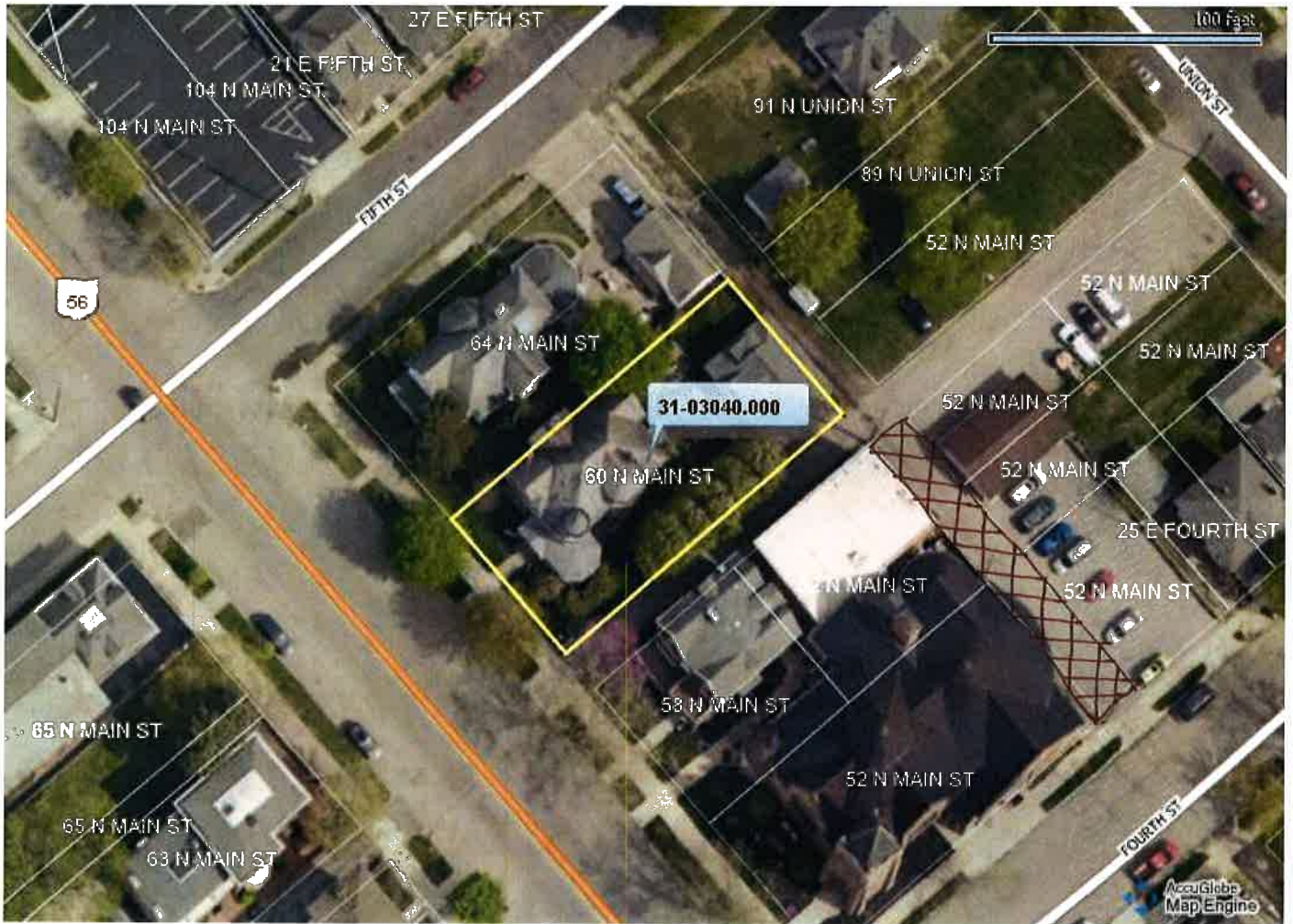
