**ORDINANCE 174-22**

**AN ORDINANCE VACATING AN ALLEY**

**WHEREAS**, the City has received a petition to vacate an alley, a copy of which is attached hereto as Exhibit A; and

**WHEREAS**, the petition has been consented to, as evidenced by the signature of all owners of property abutting the alley sought to be vacated, attached as Exhibit A;

**WHEREAS**, Council, after public hearing, and the consent of all property owners abutting the alley, is satisfied that there is good cause for such vacation, that it will not be detrimental to the general interest and that it should be made;

**NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LONDON, STATE OF OHIO**

**SECTION I:**

That the alley depicted in the map attached to Exhibit A be and the same hereby is vacated.

**SECTION II:**

That the Clerk of this Council is hereby directed to file certified copies of this Ordinance with the Madison County Auditor and Madison County Recorder.

**SECTION III:**

That this ordinance shall take effect and be in full force from and after the earliest period allowed by law.


