A RESOLUTION ASSESSING THE COSTS AND COLLECTING DELINQUENT WATER CHARGES

WHEREAS, Section 743.04 of the ORC authorizes the City to assess and collect water charges when they are not paid when due from any property located within the city when the owner of the property fails to make such payment; and

WHEREAS, Section 743.04 of the ORC authorizes the city to assess and collect water charges to the property owner or owners; and

WHEREAS, Section 743.04 of the ORC further authorizes the city to certify to the County Auditor the unpaid charges for collection as other taxes and assessments are collected when the property owner or owners have failed to pay the charges after due notification from the city; and

WHEREAS, the City has identified property owners who have been delinquent, thereafter from several properties in the city and the owner or owners have refused to pay the costs thereof after having received due to notification from the city.

NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF LONDON, STATE OF OHIO

SECTION I:

The following amounts have been charged to the properties listed below for costs incurred due to the delinquent water charges:

The amounts listed in Section 1 above shall be certified to the County Auditor for collection as other taxes and assessments are collected.

SECTION III:

The clerk is hereby authorized to certify a copy of this ordinance to the County Auditor.

SECTION IV:

That this Ordinance is hereby declared an emergency measure necessary for the immediate preservation of the public peace, health and safety of the City to take effect and be in full force immediately upon its passage.
