A RESOLUTION AUTHORIZING THE ADMINISTRATOR TO EXECUTE NECESSARY PAPERWORK TO HAVE THE CITY OF LONDON JOIN THE MID-OHIO REGIONAL PLANNING COMMISSION

WHEREAS, the City of London recognizes the need for collaborative, cooperative planning in order to ensure continued growth and prosperity;

WHEREAS, the Mid-Ohio Regional Planning Commission's Mission Statement indicates it is "The regional voice and a catalyst for sustainability and economic prosperity in order to secure a competitive advantage for central Ohio;"

WHEREAS, the Mid-Ohio Regional Planning Commission currently includes over 60 local governments and has for over 60 years addressed challenges and opportunities associated with growth and development in central Ohio, as well as working with its members to improve the quality of life within the region; and

WHEREAS, the City of London believes it would be advantageous for London to join the Mid-Ohio Regional Planning Commission and to take advantage of the opportunities provided within that organization as a means of benefitting the citizens of London.

WHEREAS, the City of London agrees to enter into the Articles of Agreement of the Commission and established Bylaws.

NOW THEREFORE, LET IT BE RESOLVED BY THE COUNCIL OF THE CITY OF LONDON, STATE OF OHIO

SECTION I:

The Administrator is authorized to execute necessary documentation and the Fiscal Officer is authorized to remit the membership dues to join the Mid-Ohio Regional Planning Commission. Furthermore, the City of London hereby appoints Patrick Closser and Rex Castle as their representatives for the Mid-Ohio Regional Planning Commission.

SECTION II:

It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public and in compliance with all legal requirements, including § 121.22 of the Ohio Revised Code.

SECTION III:

That this Ordinance shall take effect and be in full force from and after the earliest period allowed by law.
